OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

BY ENTERING THIS SWEEPSTAKES, YOU AGREE TO THESE OFFICIAL RULES (“RULES”).

1. SPONSOR: Disney Worldwide Services, Inc., dba D23 Worldwide, 500 S. Buena Vista Street, Burbank, CA 91521-8440 (“**Sponsor**”).

2. ELIGIBILITY: The D23 Season of Magic Sweepstakes Week 3 (“**Sweepstakes**”) is open only to legal residents of the 50 United States and District of Columbia (“**Territory**”) who are at least eighteen (18) years of age or older at the time of entry (or the age of majority in their jurisdiction of residence, whichever is older). Employees of Sponsor or any organizations responsible for administering, fulfilling, advertising or promoting this Sweepstakes and/or their respective parent, subsidiary, affiliated and successor companies, (collectively, “**Promotion Entities**”) and their immediate family members and household members are not eligible to enter or win a prize. “**Immediate family member**” shall mean parents, step- parents, children, step-children, siblings, step-siblings or spouses, regardless of where they live. “**Household member**” shall mean people who share the same residence at least three (3) months a year, whether related or not. Void where prohibited.

3. ENTRY PERIOD: This Sweepstakes starts at 12:00 AM ET on December 15, 2022 and ends at 11:59 PM ET on December 23, 2022 (“**Promotion Period**”), conducted as nine (9) separate and distinct drawings (each a “**Drawing**” and collectively referred to as “**Drawings**”) (see chart below for details). For purposes of these Rules, all times and days are Eastern Time. Sponsor’s computer shall be the official clock for all matters related to this Sweepstakes. Entries (as defined below) for each Drawing will not roll over into subsequent Drawings. To be eligible for each Drawing, you must enter during the respective Entry Period (defined in the chart below).

4. HOW TO ENTER: To participate in this Sweepstakes, you must have a current D23 member account (“Account”). If you do not have an Account, go to <https://d23.com/d23-membership/> and create an Account according to the instructions on the website. Becoming a D23 General Member is free. Please note that you must agree to comply with the Disney Terms of Use in order to create an Account available at <https://disneytermsofuse.com> (“Terms of Use”).

To enter this Sweepstakes, visit <https://d23.com/seasonofmagic> (“Website”) and complete the entry form for one (1) entry into this Sweepstakes (each, an “Entry” and collectively, “Entries”). You must confirm you meet the eligibility requirements and have read and agreed to the Terms of Use and these Rules in order to enter. You are solely responsible for updating the contact information associated with your Account.

Normal internet access and usage charges imposed by your internet service provider may apply.

5. Elements of each prize pack will be determined at the sole discretion of Sponsor. Gift cards may be subject to additional terms and conditions. There will be a total of nine (9) Winners (one (1) Winner per Drawing) in this Sweepstakes. The decisions of Sponsor shall be final and binding. Odds of winning a Drawing depend on the total number of eligible Entries received during the applicable Entry Period for that Drawing.

9. WINNER NOTIFICATION: On or about five (5) business days after the “Drawing Date” specified in the chart above, Sponsor will notify potential Winners via email (“Notification”). In order to be declared a Winner, you must meet the eligibility requirements in Section 2 above. Upon initial Notification by Sponsor, potential Winner must contact Sponsor at the email address or phone number provided by Sponsor and provide Sponsor with their contact information (name, email address, U.S. shipping address and/or phone number). In the event of a dispute regarding the identity of the person submitting an Entry,

the Entry will be deemed to be submitted by the person in whose name the email address or Account is registered.

Failure to respond to Sponsor within two (2) days of Sponsor's first Notification attempt, or return of Sponsor's Notification message as undeliverable, may result in disqualification and the selection of an alternate potential Winner, time permitting. The prize packs will be awarded, provided they are validly claimed within three (3) days of verifying eligibility, after which Sponsor will make reasonable efforts to select an alternate Winner, time permitting. Potential Winner may be required to sign and return to Sponsor, within two (2) days of the date notice is sent, an affidavit of eligibility, and a liability/publicity release (except where prohibited).
