

THE D23 GUARDIANS OF THE GALAXY: COSMIC REWIND SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM THE PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The D23 Guardians of the Galaxy: Cosmic Rewind Sweepstakes ("Sweepstakes") is sponsored by Disney Worldwide Services, Inc., dba D23 Worldwide ("Sponsor"), 500 S. Buena Vista Street, Burbank, CA 91521 and is administered by Prize Logic, LLC, ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on May 23, 2022 at 12:00 AM Eastern Time ("ET") and ends on June 10, 2022 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
- 2. ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States (including the District of Columbia) who are at least eighteen (18) years old or the age of majority in your state of primary residence (whichever is older), and who are a D23 Member (General or Gold Membership) at the time of entry. To become a D23 General Member, visit <https://d23.com/d23-membership/>, agree to comply with the Disney Terms of Use and create an account. Becoming a D23 General Member is Free. Employees of Sponsor, Administrator, Disney Destinations, LLC ("Prize Provider"), and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

- 3. HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, an eligible entrant may visit d23.com/entry/cosmic-rewind-sweepstakes ("Website") and complete and submit the registration form including, but not limited to: first and complete last name (no initials), valid e-mail address, phone number, street address (no P.O. Boxes will be allowed), city, state, and zip code. Upon the successful submission of the registration information, an entrant will receive one (1) entry into the Sweepstakes.

Entry Limit: There is a limit of one (1) entry per person during the Sweepstakes Period. If more than one (1) entry is received from the same person, telephone number and/or e-mail address the entries may, at the Sponsor's sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor's sole discretion, may not be eligible to win a prize. A "day" is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on a calendar day during the Sweepstakes Period.

4. **RANDOM DRAWING:** On or around June 13, 2022, the Administrator will randomly select one (1) potential winner from all eligible entries received. The winner is considered a potential winner pending verification of eligibility and compliance with these Official Rules.
5. **PRIZE, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:**
 - A. **Prize (1):** The prize is a four (4)-night trip for four (4) to *Walt Disney World*® Resort ("Prize") for winner and up to three (3) guests to *Walt Disney World*® near Orlando, FL ("Resort") consisting of the following:
 - i. round trip coach airfares between the major United States gateway airport closest to winner's residence and the Orlando International Airport (with possible layovers); provided, however, if winner resides within 250 miles of the Resort, airfare will not be provided;
 - ii. round trip ground transportation between the Orlando International Airport and the Resort; provided, however, if winner resides within 250 miles of the Resort, ground transportation will not be provided;
 - iii. room accommodations consisting of one (1) standard room (with a maximum of four [4] persons per room) for one (1) night at a hotel selected by Sponsor or Prize Provider in its sole discretion, based on availability;
 - iv. one (1) Memory Maker product which includes unlimited digital downloads of *Disney PhotoPass*® photos captured during the vacation and linked to the Prize winner's Disney account (online registration required; terms and conditions apply: <https://disneyworld.disney.go.com/photopass-terms-conditions/>);
 - v. four (4) 5-Day Theme Park Admission Tickets with *Park Hopper*® Option (Theme park reservation required; blackout dates apply and are to be determined at the sole discretion of Sponsor); and
 - vi. one (1) \$500 USD Disney Gift Card for winner only (subject to restrictions; <https://www.disneygiftcard.com/terms/us>).

No more than one (1) Prize will be available in the Sweepstakes. The ARV of the Prize is \$9,440.04. The actual value of the trip may vary depending on point of departure and fluctuations in the cost of air transportation. Any difference between the estimated ARV and the actual value of the Prize will not be awarded. No compensation will be provided for any difference in Prize value.

- B. **Prize Additional terms & Conditions:** In no event will more than one (1) Prize, be awarded. If the winner elects to travel or partake in the Prize without guests, the Prize will be awarded in increments suitable for the actual number of guests and no additional compensation will be awarded to the winner. C. Odds of Winning: The odds of winning the Prize depend on the number of eligible Sweepstakes entries received during the Sweepstakes Period.

6. HOW TO CLAIM THE PRIZE: The potential winner is subject to verification of eligibility and compliance with these Official Rules. After the random drawing, Administrator will notify the potential winner via e-mail at the e-mail address provided at the time of registration. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE**

OR ANY OTHER EQUITABLE RELIEF.
