I ACKNOWLEDGE THAT MY PARTICIPATION AND/OR APPEARANCE MAY BE CONSIDERED AN INHERENTLY DANGEROUS ACTIVITY AND I AGREE TO ASSUME THE RISKS incidental to such participation and/or appearance and, on my own behalf, and on behalf of my heirs, executors and administrators, **RELEASE** and forever discharge Disney of and from all liabilities, claims, actions, damages, costs or expenses of any nature arising out of or in any way connected with my participation in such activity, and further agree to indemnify and hold Disney harmless against any and all such liabilities, claims, actions, damages, costs or expenses, including, but not limited to, attorneys' and other professionals' fees and disbursements. This Consent shall be binding upon me, and my heirs, personal representatives and assigns, and shall be governed by and construed under the laws of the State of California, without regard to conflicts of laws principles. Venue for any legal action arising out of or in connection with this Consent shall be in Los Angeles County, California and jurisdiction shall be vested exclusively in the Los Angeles Superior Court or, if appropriate, in the Federal District Court in Los Angeles, and I waive my right to a trial by jury. If any provision of this Consent is deemed to be invalid, it shall be considered deleted herefrom and shall not invalidate the remaining provisions. This Consent constitutes my entire agreement in favor of Disney with respect to the subject matter of this Consent and supersedes any and all of my previous agreements, statements, communications and representations, whether written or oral, in favor of or with Disney with respect to such subject matter.
