

## **AUTHORIZATION TO REPRODUCE PHYSICAL LIKENESS OF MINOR (“Release”)**

### **Event: An Evening with Rick Riordan – 8/14/2025 (“Campaign”)**

In consideration of the publicity and exposure I may receive if included in the Project (as defined below) and for other good and valuable consideration, the sufficiency and receipt of which are acknowledged, I hereby grant to **Disney Consumer Products, Inc.** and its related, affiliated and subsidiary companies, assigns and licensees (“**Disney**”) the right (i) to photograph, record, depict and/or portray me in connection with the Campaign shoot and related activities (the “**Project**”), and (ii) to use, reproduce, display, edit, and/or otherwise modify, in whole or in part, my actual or simulated likeness, name, place of employment, title, photograph, voice, actions, etc. as they appear/sound in such photographs, recordings, depictions and/or portrayals (collectively, “**My Likeness**”), in perpetuity throughout the Universe, in all forms and in all media, now known or hereafter devised, for any and all purposes related to a Disney-authorized activity, including, but not limited to, advertising, promotional, and marketing activities (collectively, the “**Authorized Purposes**”).

I represent that the consent of no other person, firm, corporation or labor organization is required to enable Disney to use My Likeness for the Authorized Purposes and that such use will not violate the rights of any third parties. I agree that all results and proceeds of my participation in the Project, and the Project, shall be the sole property of Disney or its designee.

I acknowledge that nothing herein requires Disney to use My Likeness for the Authorized Purposes, nor to accord me credit. I waive any right that I may have to inspect and/or approve the use of My Likeness and hereby release Disney from all liability in connection therewith.

I hereby release Disney and their respective officers, directors, agents, employees and vendors from any and all claims, actions, causes of action, demands, rights, damages, costs, loss of service, expenses, and compensation whatsoever, known or unknown, foreseen and unforeseen, which may occur as a result of Disney’s use of my Likeness in connection with the Project, including, without limitation, for any violation of any rights of privacy, publicity, defamation, or any other personal or property right. In no event shall I have any right to seek or obtain injunctive relief or other equitable relief with respect to this Release.

This Release will be binding upon me, and my heirs, personal representatives and assigns and will be governed by and construed under the laws of the State of California, without regard to conflicts of laws principles. Any legal action arising out of or in connection with this Release shall be submitted to the exclusive jurisdiction of the Los Angeles County courts, and I hereby waive any defenses or objections based on lack of jurisdiction, improper venue, and/or forum non conveniens. I waive my right to a trial by jury. If any provision of this Release is deemed to be invalid, it will be considered deleted herefrom and will not invalidate the remaining provisions. I acknowledge that this Release represents the entire agreement between Disney and me with respect to Disney’s right to use My Likeness. Moreover, I acknowledge that this Release supersedes any prior or contemporaneous agreements and statements, whether written or oral, concerning such rights, and that in the event of any conflict between this Release and any other document pertaining to such rights, this Release shall control.

I hereby certify and represent that I have read the foregoing and fully understand the meaning and effect thereof and, intending to be legally bound, I have signed this Release on the date set forth below.
