

**RELEASE AND WAIVER OF LIABILITY AGREEMENT**

As consideration for being permitted to participate in the Activity, I forever release Disney Worldwide Services, Inc., and its respective parents, affiliates, subsidiaries, successors, assigns, and all of their respective officers, directors, shareholders, employees, agents, and representatives, subcontractors and insurers, production companies, all other sponsors and advertisers of the Event, and all owners or lessors of premises used in connection with the Event (collectively, the “Released Parties”) from any and all actions, claims, or demands that I, my assignees, heirs, distributees, guardians, next of kin, spouse and legal representatives now have, or may have in the future, for injury, death, or property damage, related to (i) my participation in the Activity, (ii) the negligence or other acts, whether directly connected to the Activity or not, and however caused, by any of the Released Parties, or (iii) the condition of the premises where the Activity occurs, whether or not I am then participating in the Activity. In other words, **I AGREE TO HOLD THE RELEASED PARTIES COMPLETELY HARMLESS AND NOT LIABLE AND RELEASE THE RELEASED PARTIES FROM ALL LIABILITY WHATSOEVER.** I also agree that I, my assignees, heirs, distributees, guardians, next of kin, spouse and legal representatives will not make a claim against, sue, or attach the property of the Released Parties in connection with any of the matters covered by the foregoing release.

I further certify and agree that: (1) I will review and obey all rules of the Activity, (2) I will heed the instruction and warnings of the Activity’s supervisors, and (3) I acknowledge that Activity’s supervisors reserve the right to terminate my participation in the Activity if, at any time, any rules are not followed or my behavior is deemed unsafe or disruptive for any reason.
