

## D23 MOVIE FAN SWEEPSTAKES – TRON: ARES

### OFFICIAL RULES

***NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.***

***BY ENTERING THIS SWEEPSTAKES, YOU AGREE TO THESE OFFICIAL RULES (“RULES”).***

**1. SPONSOR:** Disney Worldwide Services, Inc., dba D23 Worldwide, 500 S. Buena Vista Street, Burbank, CA 91521-8440 (“**Sponsor**”).

**2. ELIGIBILITY:** To be eligible for this sweepstakes (“**Sweepstakes**”), at the time of entering you must be: [a] at least eighteen (18) years of age or older as of time/date of entry; and [b] a legal resident of one (1) of the fifty (50) United States or the District of Columbia. Entrants cannot be employees of Sponsor, its parent, subsidiary or affiliated companies, or of the advertising, promotional or fulfillment agencies of any of them (individually and collectively, “**Entities**”), or members of their respective households (defined as people who share the same residence at least three (3) months a year, whether related or not) or immediate families (defined as parents, children, siblings, step-parents, step-children, step-siblings and their spouses). Void where prohibited and subject to all applicable federal, state, local and municipal laws and regulations.

**3. ENTRY PERIOD:** This Sweepstakes begins with Sponsor’s Sweepstakes announcement post on Sponsor’s official D23 account on Instagram (@DisneyD23) (“**Sponsor’s Account**”) **on or about 11:00 am PT on October 6, 2025 and ends at 11:59 pm PT on October 8, 2025 (“Entry Period”).** Sponsor may post one (1) or more subsequent Sweepstakes reminder posts to Sponsor’s Account (each, a “**Sweepstakes Announcement**”) during the Entry Period. For purposes of these Rules, all times and days are Pacific Time. Sponsor’s computer shall be the official clock for all matters related to this Sweepstakes. The Sweepstakes will consist of four (4) drawings (each a “**Drawing**” and collectively referred to as “**Drawings**”).

**4. HOW TO ENTER:** To participate in this Sweepstakes, you must have an active Instagram account (“**Account**”) in good standing. If you do not have an Account, download the Instagram app from the Apple App Store or Google Play onto a compatible mobile device or visit <https://www.instagram.com/> and create an Account according to the instructions provided. Creating an Account is free. You must accept the Instagram Terms at <https://help.instagram.com/581066165581870> to create an Account and you must be logged in to your Account in order to enter this Sweepstakes.

Once you have logged in to your Account you may enter this Sweepstakes by following Sponsor’s official Account on Instagram (@DisneyD23) and commenting on the Sponsor’s post announcing the sweepstakes. The comment must include the hashtag “#D23Sweepstakes” (“**Required Post Elements**”). A comment on the Sponsor’s Sweepstakes Announcement that contains the Required Post Elements will count as one (1) entry into this Sweepstakes (individually, an “**Entry**” and collectively, “**Entries**”).

If your Account is private or posted content is otherwise inaccessible to Sponsor, your comment with the Required Post Element may not result in a valid Sweepstakes Entry. All incomplete, misspelled, incorrect or non-conforming Entries as may be required will be disqualified.

Use of the Instagram app requires a compatible mobile device. Message and data rates imposed by your mobile service provider may apply. Use of Instagram requires internet access. Normal internet access and usage charges imposed by your internet service provider may apply. Subject to all applicable federal, state, provincial, territorial, local and municipal laws and regulations.

**5. PROHIBITED CONTENT:** You agree that your Entry will not contain any content that would infringe or violate any right of a third party including without limitation: (a) copyright, patent, trademark, trade secret or other proprietary or contractual rights (this includes any trademark, trade name or logo of any third party or naming/referencing/depicting a third party (living or dead) without their written consent); (b) right of privacy (specifically, you must not distribute another person's personal information of any kind without their express permission) or publicity; or (c) any confidentiality obligation.

In addition to the foregoing requirements, Entries may not contain, and Sponsor, in its sole discretion, may disqualify any Entry that: (i) is sexually explicit or suggestive, dangerous, unnecessarily violent or derogatory of any ethnic, racial, gender, religious, professional or age group, profane or pornographic, or contain nudity; (ii) promotes alcohol, illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing), any activities that may appear unsafe or dangerous, or any particular political agenda or message; (iii) is obscene or offensive, or endorses any form of hate or hate group; (iv) defames, misrepresents or contains disparaging remarks about Sponsor, or other products, people or companies; (v) contains trademarks, logos or trade dress (such as distinctive packaging or building exteriors/interiors) owned by others, or advertises or promotes any brand or product of any kind, without permission, or contains any personal identification, such as license plate numbers, personal names, e-mail addresses or street addresses; (vi) contains copyrighted materials owned by others (including music, photographs, sculptures, paintings and other works of art or images published on or in websites, television, movies or other media) without permission; (vii) contains materials embodying the names, likenesses, photographs, or other indicia identifying any person, living or dead, without permission; (viii) communicates messages or images inconsistent with the positive images and/or goodwill to which Sponsor wishes to associate; and/or (ix) is in violation of any law or regulation. Entries that do not meet the requirements and specifications listed above and that are otherwise inappropriate, objectionable, or unsuitable for the uses contemplated in these Rules, may be disqualified, as determined by Sponsor in its sole discretion. Once an Entry is submitted, it cannot be modified.

**6. LIMITATIONS:** Limit one (1) Entry per Entry Period, regardless of the number of email addresses or Accounts a person may have or whether more than one person uses the same email address or Account. All Entries must be received during the Entry Period to be eligible. Proof of submission of Entry does not constitute proof of receipt of same. By entering this Sweepstakes, entrants agree to these Rules and the decisions of Sponsor, which are binding and final in all matters relating to this Sweepstakes and not subject to appeal. Any attempt by a person to use multiple email addresses or Accounts to enter more than allowed by these Rules may result in disqualification at Sponsor's sole discretion. Entries that do not conform to or that violate these Rules or are submitted in any manner other than set forth in these Rules are void and will be disqualified. Any use of automated or programmed methods of Entry are prohibited. Neither the Promotion Entities, nor any of their respective officers, directors, shareholders, employees, agents or representatives (individually and collectively, "**Released Parties**") are responsible for any of the following: Entries from persons residing, or physically located, outside the Territory; or Entries that are altered, delayed, deleted, destroyed, forged, fraudulent, improperly accessed, inaccurate, incomplete, interrupted, irregular in any way, late, lost, misdirected, multiple, non-delivered, stolen, tampered with, unauthorized, unintelligible or otherwise not in compliance with these Rules; or for lost, interrupted or unavailable network, server, internet service provider, or other connections; telephone or internet availability or accessibility; miscommunications; failed computer, satellite, telephone or cable transmissions, lines or technical failure; failed phone, computer hardware or software failures, technical errors or difficulties; technical failures; unauthorized human intervention; traffic congestion; garbled or jumbled transmissions; undeliverable emails resulting from any form of active or passive email filtering; insufficient space in entrant's email account to receive email; or other errors of any kind, whether due to electronic, human, mechanical, printing, production or technical errors or other causes; even if caused by the negligence of any of the Released Parties. Released Parties are not responsible for any changes or unavailability of the Instagram app, platform, or functionalities that may interfere with this Sweepstakes (including any limitations, any restrictions, or any conditions on Sponsor's ability to use Instagram for this Sweepstakes as set forth herein) or ability of entrant to timely enter, receive notices or communicate with Sponsor via Instagram direct message, in which case Sponsor, in its sole discretion, may modify or terminate this Sweepstakes.

**7. PRIZES:** Four (4) winners will each receive two (2) \$20 Fandango Promo codes, each good towards a movie ticket to see *TRON: Ares* in theaters, one (1) *TRON: Ares* Adult Cap, one (1) *TRON: Ares* LED bracelet, and two (2) *TRON: Catalyst* Steam game digital redemption codes. Approximate retail value ("**ARV**") for each Prize is Ninety-Five Dollars and Seventy Cents (\$95.70). Total ARV of all Prizes being awarded: Three Hundred Eighty-Two Dollars and Eighty Cents (\$382.80).

**Prize Conditions:** Elements of the prize pack will be determined at the sole discretion of Sponsor. Winner is not entitled to exchange or transfer the prize pack or to obtain cash or other substitutes, except Sponsor reserves the right to substitute a prize pack or portions thereof of equal or greater value if a prize pack listed or any portion thereof is unavailable for any reason. Each digital redemption code for TRON: Catalyst Steam game (each, a “Game Code”), two Games Codes per winner, is valid for a single redemption on one account only and shall only be transferred in accordance with the D23 Movie Fan Sweepstakes – *TRON: Ares* Rules by a winner to an eligible recipient of the Game Code. Any transfer of a Game Code outside of the scope of the D23 Movie Fan Sweepstakes – *TRON: Ares* Rules will be void. Each Game Code may not be transferred, exchanged or redeemed for cash. Game Codes must be redeemed by 12/31/2026, after which time they will be void. Lost, stolen, or expired Game Codes will not be replaced. WINNER SELECTION:** There will be a total of four (4) Winners in this Sweepstakes who will be randomly selected from among all eligible Entries received during the applicable Entry Period by the Sponsor on or about October 9, 2025. The decisions of the Sponsor shall be final and binding. Odds of winning depend on the total number of eligible Entries received.

**9. WINNER NOTIFICATION:** Sponsor will send a direct message to each potential winner within approximately twenty-four (24) hours of drawing (“**Notification**”). In order to be declared a winner, you must meet the eligibility requirements in Section 2 above. Upon initial Notification by Sponsor, potential winner must contact Sponsor as specified (e.g., via direct message response or at the email address or phone number provided by Sponsor) and provide Sponsor with their contact information (name, email address, U.S. shipping address and phone number) within one (1) day of the time Sponsor sent you the Notification. In the event of a dispute regarding the identity of the person submitting an Entry, the Entry will be deemed to be submitted by the person in whose name the email address or Account is registered.

Failure to respond to Sponsor within one (1) day of Sponsor’s first Notification attempt, or return of Sponsor’s Notification message as undeliverable, may result in disqualification and the selection of an alternate potential winner, time permitting. The prizes will be awarded, provided they are validly claimed within one (1) day of verifying eligibility, after which Sponsor will make reasonable efforts to select an alternate Winner, time permitting. Sponsor is not responsible for changes to the Instagram app, direct message feature, the Instagram post function or email or telephone functionality issues that may interfere with winner Notification. Potential winners may be required to sign and return to Sponsor, within one (1) day of the date Notification is sent, an affidavit of eligibility, and a liability/publicity release (except where prohibited).

In the event of a prize forfeiture, Sponsor may, in its sole discretion, award or not award the forfeited prize to an alternate winner.
